omeone please tell me that the National Republican Congressional Committee is not populated with crazy people!

The Committee is asking the FCC to stop the John and Ken Show from trying to get Republican Congressman David Dreier defeated at the polls.

Listeners to the John and Ken Radio Show on KFI, Los Angeles, know that generally the show supports Republican candidates and conservative policies. In the last State election, the show was a HUGE opponent of Governor Davis, and a HUGE supporter of now-governor Arnold – in fact, the show led and promoted a caravan to Sacramento to oppose Governor Davis.
